

**NOTICE IS GIVEN** that on **Wednesday, December 16, 2020 at 7:00 p.m.**, prevailing time, Council for the Borough of West Chester, Chester County, Pennsylvania, will hold a public hearing as part of the regularly scheduled public meeting to consider the adoption of, and if approved, Borough Council will adopt an ordinance with the following title and summary:

**AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 104 TITLED "VEHICLES AND TRAFFIC", SECTION 104-32 TO PROHIBIT PARKING ON THE EAST SIDE OF N. BRANDYWINE STREET ON WEDNESDAY 8:00AM-11:00AM FROM W. GAY STREET TO W. CHESTNUT STREET AND ON THE WEST SIDE OF N. BRANDYWINE STREET ON THURSDAY FROM 8:00AM-11:00AM FROM W. GAY STRET TO W. CHESTNUT STREET AND SECTION 104-88 TO REPLACE THE BOND REQUIREMENT FOR GARAGES THAT STORE IMPOUNDED VEHICLES WITH A REQUIREMENT TO OBTAIN GENERAL LIABILITY INSURANCE AND GARAGEKEEPERS INSURANCE.**

ORDINANCE NO. - 2020

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, CHAPTER 89, TITLED, "SEWERS", SECTION 89-11(B) TO REVISE THE MONTHLY SEWER RATES EFFECTIVE FEBRUARY 1, 2021.

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

**SECTION 1.** Chapter 89 of the Code of the Borough of West Chester, titled, "Sewers", Section 89-11 is hereby amended as follows:

"B. Effective January 1, 2021, the monthly sewer rates shall be computed as follows:

**Monthly Sewer Rates**

<b>Quantity of Water Used in gallons</b>	<b>Charge</b>
First 2,000 or less	\$30.11
Over 2,000	\$7.99 per 1,000 gallons or any part thereof"

**SECTION 2. SEVERABILITY.** If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

**SECTION 3. REPEALER.** All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 4. EFFECTIVE DATE.** This Ordinance shall become effective upon enactment as provided by law.
